5. I am not eligible to make an Academic Appeal for a full tuition refund for any class(es) for which I fail to request the drop by the Drop/Add deadline.
6. Should I not pay tuition and fees by the payment deadline, all of my classes will be canceled; this may affect my financial aid awards
7. I have the opportunity, for a limited time, to have my classes restored with the full and immediate payment, including the late registration fees and other payment obligations.
8. FIU Email is the e-address to which all official notices from the university, college, and program will be sent.

If applicable, I acknowledge that my responsibility is to review and understand the "Terms and Conditions" of my financial aid awards. I understand that my financial aid is based on full-time enrollment (Graduate-9 credits) and will be adjusted according to my enrollment at the end of the Drop/Add period.
