ADMISSIONS REQUIREMENTS:

- \$30 application fee
- · Current enrollment in an undergraduate or graduate degree program at a partner institution
- Nomination from a partner program
- · Financial statement
- · Copies of transcripts and diplomas from all undergraduate and graduate degree programs
- Students from non-English speaking countries must demonstrate proficiency in the English language. Applicants must present a minimum score of 550 paper-based or 80 internet-based ("iBT") score on the Test of English as a Foreign Language ("TOEFL"), a minimum of 6.5 on the International English Language Testing System ("IELTS"), or a minimum of 110 on the Duolingo English Exam. Students applying from partner universities under approved agreements whose programs are fully taught in English or have similar English-language proficiency requirements comparable to FIU may demonstrate they meet this requirement

WHAT IS THE PRICE OF THE PROGRAM?

- Tuition fees vary by course and are subject to change; approximately 1,900 USD per undergraduate course or approximately 3,000 USD per graduate course
- Housing expenses are paid separately and range from \$700 to \$1,100 per month; student fees for campus services are \$199
 per semester
