EMMANUEL N. ROUSSAKIS is Emeritus Professor of Finance at the College of Business of Florida International University in Miami, Florida. He is also a recipient of several U.S. Department of State awards--Fulbright Specialist in Cyprus (2022), Tunisia (2020), Kuwait (2017), Morocco (2014), Indonesia (2013) and Russia (2012), Lecturer at the Fulbright International Summer Institute in Bulgaria (2011), and Fulbright Scholar in Romania (2010).

His employment record includes serving on the board of directors of an American bank, consulting government agencies in the United States and Europe, and participating in the negotiations for Greece's admission to the European Economic Community in the area of commercial banks and banking policy. He was co-recipient of a Florida State Research (STAR) grant for the study of international banking legislation and taxation; study recommendations were the basis for legislative changes implemented in Florida in July 1979 and June 1980, respectively. Dr. Roussakis has published widely on banking subjects, and his articles have appeared in academic and professional journals in the United States, Europe and Latin America. He is the author of Friedrich List, the Zollverein and the Uniting of Europe (College of Europe Press, 1968), Managing Commercial Bank Funds (Praeger, 1977), Miami's International Banking Community: Foreign Banks, Edge Act Corporations and Local Banks (Peat, Marwick, Mitchell & Co., 1981), Commercial Banking in an Era of Deregulation, 3rd edition (Praeger, 1997), and Basics of International Banking, 2nd edition (XanEdu, 2021). Dr. Roussakis is also the editor of, and contributor to, International Lending by U.S. Commercial Banks: A Casebook (Praeger, 1981), International Banking: Principles and Practices (Praeger, 1983), and Cases in Commercial Bank Management (Kolb Publishing Co., 1994). His book Commercial Banking in an Era of Deregulation, 2nd edition, was translated into Chinese and published by the China Price Publishing, Beijing, in 1992.

He was instrumental in establishing the department of Finance and developing its banking curriculum. He taught graduate and undergraduate courses in commercial and international banking and global financial strategy and developed and directed certificate programs and courses/seminars for professionals in the financial industry. He has lectured bank managers and trainees in development programs in the United States and abroad, and on several occasions he offered expert testimony in bank litigation For his many and varied contributions to FIU and the community at large, he received 9 awards for exceptional performance in teaching, scholarship and service. He served as department Chair (2000-2003) and was recognized for his sustained contributions in the field of international banking through the award of the Florida International Bankers Association (FIBA) endowed chair in Finance (1999-2003). He contributed to the development of the College's graduate programs downtown by serving as the Director of the Professional MBA, and the Master of Science in Finance (2006-2010).

Although associated with FIU since 1976, during a three-year interval (2003-2006) he was Dean of the School of Business at the University of Nicosia, the largest private graduate and undergraduate educational institution in Cyprus. He provided management and leadership to the faculty and students at the school, was responsible for the curriculum development and instructional quality of programs and courses and developed and maintained a working relationship with the business community.

Dr. Roussakis holds degrees from the University of Athens, Atlanta University, the College of Europe, and the Catholic University of Leuven where he received his doctorate in economics. He speaks fluently English and Greek, and has knowledge of French, Spanish and Arabic.

### **Achievements**

Director Directed the College's downtown MBA (2007-10) and MSF (2006-09) programs recruiting students and faculty, preparing curriculum, and taking responsibility for program review. Run over a 12-month period the Downtown MSF started with an initial intake of 14 students (2006) and increased to over 30. The MBA, known as "Professional MBA," run over an 18-month period and its single cohort of 30 students (2007) was increased to two cohorts per year, with an average enrollment of 45 students each (an 18-month cash flow of \$3.7 million initiated each fall term).

Director As the College's first Assurance of Learning (AOL) Director I sought to address a wide spectrum of issues. Held meetings with Department Chairs to review adopted AOL procedures and encourage their proactive engagement in AOL activities. Met with the core course coordinators to facilitate consensus-driven decisions toward the establishment of congruent syllabi for all (onsite, hybrid, online) sections of a course. This involved assembling the team of course instructors, establishing team purpose and objectives, facilitating team engagement and interaction, and driving consensus on the course syllabus elements. Still another aspect entailed monitoring and disseminating faculty-driven AOL progress college-wide. Major AOL constituents were asked to contribute, by rotation, to the College's monthly issue (Inside Business) a report on any AOL progress attained. In time these reports became a regular feature of this publication increasing faculty awareness and contributing to standardization. Other tasks included the establishment of AOL committees, defining their duties and responsibilities, addressing occasional individual faculty issues, and interacting regularly with the Associate Dean.

Dean Restructured the School of Business from two units to five departments with corresponding heads; developed the School's website; created two business student organizations

and supported their activities; established the internship program; oversaw the accreditation (or reaccreditation) of undergraduate and graduate programs, and promoted the introduction of new ones; supported structures and process for faculty research and applications for substantial grant monies; oversaw the recruitment of new faculty; created the MBA mentors group to provide professional advice and guidance to students in the program; formed an Advisory Council of prominent business executives; and initiated the establishment of a forum for business leaders in the community to exchange ideas and discuss issues and challenges following the country's accession into the European Union.

Chair During my tenure as Chairperson, I actively promoted the reorganization of the graduate program and implemented the Master of Science in Finance (MSF)-Fast Track (FT). Introduced in January 2001, the MSF-FT has been structured as a lock step, eleven-course, twelve-month executive program, enabling participants to benefit from its cohesive and progressive design and from sharing their unique perspectives and experiences with each other. Since its establishment, the program has grown significantly and is currently offered in three campuses, with a different focus on each case-- in the Mitch Maidique/University Park the focus is corporate finance, in Pines investments, and in Brickell/Downtown commercial and international banking. Cohorts in all three campuses are admitted annually (January and August).

Gained approval from the Dean of the College of Business Administration to re-establish the departmental Ph.D. program that was phased out several years earlier. This approval was granted due to the department's research productivity and the securing of external funding. The program was implemented with the appointment of a coordinator and the initial admission of 5 graduate students in August 2002. Currently 7 graduate students are admitted every other year.

Strengthened the undergraduate program for finance majors through improvements in the curriculum and its delivery. In the former instance a course with global focus was added in the core curriculum. In the latter instance, the instruction of online/web-based courses increased. The size of undergraduate enrollment in finance amounted to about 950 students.

Supported the successful application by two faculty members who received major grants from the State of Florida. One grant was from the Florida Department of Insurance in the amount of \$2.7 million to develop and maintain a computer model to assess hurricane risks and residential losses for various state sites. The other was from the Florida Department of Community Affairs in the amount of \$100,000 to study barriers and incentives to mitigation against hurricane risk for mobile homes.

Facilitated the work of faculty members who received the University's Excellence in Teaching (3), Research (2), and Service Awards. Other faculty members (4) received awards from the College of Business Administration for their performance in these areas.

Secured renewable, six-month, \$18,000 graduate student research grants from Citibank to fund projects pertinent to the bank's Latin American operations.

Developed an internship course for the Department of Finance and managed its growth over a twenty-year period. During the 2000-03 period, average course enrollment per semester ranged between 25 and 30 students, all placed with local businesses and financial institutions. Success of

this course led to the implementation of its format and policy guidelines college wide.

Oversaw the recruitment activities and hiring of two faculty members.
