The International Business Honor Society (IBHS) will award one \$500.00 scholarship to an IBHS student member in 2013.

### SCHOLARSHIP CRITERIA

**Undergraduate** applicants must be enrolled full-time, have a cumulative GPA of at least 3.5 on a 4.0-point scale, and be admitted to the College of Business Administration (CBA).

**Graduate** student applicants must be enrolled in a Chapman business degree program and clearly pursuing an emphasis area in business or a business related program (MBA or MIB among others), and completed at least six hours of graduate course work with at least 3.5 GPA on a 4.0-point scale.

### JUDGING CRITERIA

The judging committee will evaluate scholarship applicants and select the scholarship winner based on the following criteria:

- 40% Student involvement in IBHS
- 25% Academic achievement
- 20% Letter of recommendation from a faculty member
- 15% Additional leadership and service activities/work experience

### TIMELINE

Application deadline: March 15, 2013.

Applicants notified of results: April 4th, 2013 during the Business Student Leadership Award

Ceremony. Recipient awarded in two parts: First half during the 2013 fall semester and second half during 2014 spring semester.

To be considered for the scholarship, applicants must submit the following information: Completed application

- Letter from IBHS certifying semesters' points
- Copy of your most recent unofficial University transcript
- Letter of recommendation from faculty member
- Current résumé

*\*If selected for the scholarship, students will be required to submit an official transcript at the time prior to receiving funds.*
